# LAW ENFORCEMENT, FIRE AND RESCUE & EMS PERSONNEL ARE GOING TO NEED NEW TRAINING AND DETECTION EQUIPMENT.

Our hearts go out to all of our First Responders and frontline emergency services personnel who are going to be among the first to fall to these new high-tech terrorist weapons. Information critical to their safety, readiness and their very lives, has been purposely withheld from State, County & City law enforcement agencies for the sake of 'national security'.
